Put placeholders in the text to show where the illustrations will go. Type these placeholders on their own line, flush left, and bracketed (e.g. [table 1]). At the end of the document, provide label, number, caption, and source information in an organized list.

Author's last name (no first names or initials) Year of publication (or "n.d." if there is "no date": (LastName, n.d., p.#)) Page number, paragraph number, chapter, section, or time stamp where the information can be located within the source (only required for direct quotes)

How to Cite a Chapter in a Paper You can use information from your research in three ways: Paraphrase – Take the information from a specific sentence, paragraph, or section of the article and rewrite it in your own words. Summarize – Take a larger view of the section or the chapter and rewrite it in your own words.

Ensure that each in-text citation corresponds to a full-text citation found in the "Works Cited" page of your paper. If you mention the author's name in your sentence, you may omit the name from the parenthetical citation. In these cases, your citation need only be a page number or numbers. List multiple authors as follows:

When you quote or paraphrase the white paper, MLA requires a parenthetical citation at the end of the sentence. This citation directs your readers to the full entry in your Works Cited. Use the author's name, or the title of the paper for institutional authors. Place a period outside the closing parentheses.
