A comprehensive evaluation is made of the widely used role conflict and ambiguity scales (RCA) developed by Rizzo, House and Lirtzman (1970). Data on the factor structures, means and standard deviations, internal consistency reliability, and discriminant validity were analyzed and compared to other studies on RCA scales.

## **Role Conflict and Ambiguity Scales: An Evaluation of ...**

The two scales developed and validated by Rizzo, House, and Lirtzman (1970) were used to measure role conflict and ambiguity. The role conflict scale consisted of eight items, each having a 7-point scale ranging from "very false" to "very true."

## **ROLE CONFLICT AND AMBIGUITY: CORRELATES WITH JOB ...**

A review of the previous literature on role conflict and ambiguity (Rizzo, House, and Lirtzman, 1970) supported the Kahn et al. theory, and found both conflict and ambiguity to be clearly associated with low job satisfaction and dysfunctional behavior due to the stress and anxiety of role pressures.

The scale (known as the Rizzo, House & Lirtzman or RHL scale) developed by Rizzo, et al. (1970) has been the most widely used (used in 85% of the studies according to Jackson & Schuler 1985) by researchers studying role stress (role ambiguity, role conflict, and role overload) and it is also the most widely debated.

Although research on role conflict and ambiguity has been extensive, there has been only moderate consistency in the focus and results of the research, while several areas of role conflict and ambiguity research are still relatively unexamined.

## **Role Conflict and Role Ambiguity: Integration of the ...**

In order to systematically examine the role concepts of ambiguity and conflict and their relationships with organizational and personal variables, Rizzo, House, and Lirtzman (1970) constructed, from a factor analysis of 29 items, two scales called role conflict and role ambiguity. Role conflict had eight items and role ambiguity had six items.
