The Universal Declaration of Human Rights (UDHR) is a document adopted by the United Nations General Assembly that establishes principles for the rights and freedoms of individuals. Considered a foundational text in international human rights law, it was accepted by the General Assembly as Resolution 217 at its third session on 10 December 1948 at the Palais de Chaillot in Paris, France.
